- 1 - SUBMIT A SINGLE COPY OF YOUR PUBLICATION VIA MAIL OR IN PERSON.
- 2 - WE WILL PUT THAT COPY OUT FOR SALE FOR ONE MONTH.  
YOU DETERMINE THE SALE PRICE, AND YOU RECEIVE 60 PERCENT.  
FOR EXAMPLE, IF YOUR BOOK SELLS FOR \$5, YOU GET \$3 WHEN AND WE GET \$2.
- 3 - PLEASE CONTACT US AT THE END OF THE ONE-MONTH PERIOD.  
IF YOUR SAMPLE COPY HAS SOLD, WE WILL TAKE FIVE MORE COPIES.  
IF IT HASN'T SOLD, WE WILL EITHER RETURN IT AT YOUR EXPENSE  
OR GIVE IT AWAY FOR FREE.
- 4 - IF YOU DO NOT CONTACT AT THE END OF THE MONTH AND IT HAS NOT SOLD,  
IT WILL BE CONSIDERED ABANDONED AND WILL MOST LIKELY BE GIVEN AWAY.
- 5 - IF YOUR WORK SELLS AND WE TAKE MORE COPIES, YOU ARE STILL RESPONSIBLE  
FOR CHECKING ON YOUR SALES. WHEN CHECKING ON SALES, IT IS USEFUL IF  
YOU CAN PROVIDE AN IMAGE OF THE COVER OF YOUR PUBLICATION.  
WE HAVE A LOT OF CONSIGNMENT MATERIAL, AND IT IS SOMETIMES DIFFICULT  
TO TRACK DOWN A PARTICULAR ITEM.

THE ONE-MONTH TRIAL FOR NEW SUBMISSIONS IS MANDATORY,  
AND IS THE BEST SOLUTION WE COULD FIND FOR AN OVERWHELMING AMOUNT  
OF QUALITY MATERIAL. IF IT DOESN'T SELL, WE CAN'T AFFORD THE SHELF SPACE.
